

Sisters Inspire Sdn Bhd ("Sisters Inspire") values your privacy and is committed to the protection of your personal data. This Personal Data Protection Notice ("Notice") describes how Sisters Inspire collects, handles and uses your personal data in accordance with the Personal Data Protection Act 2010.

By using our supply chain financing platform ("Platform") or submitting your own or another individual's personal data (e.g. your directors or employees), you consent to the collection, use and disclosure of your personal data by Sisters Inspire, and confirm that such other individual agrees to our collection, use and disclosure of personal data in accordance with this Notice.

Personal Data We Collect

The nature of personal data we collect, and where it comes from, will vary according to the specific Product, which you subscribe to, on our Platform. The Personal data that we may collect include names, address, government issued identification documents, contact details, credit and financial history, employment history, public and political functions and connections, and bank account information.

As part of the registration process for creating an account on our Platform and during the course of your participation in any one of our supply chain financing products made available on our Platform (each a "Product", and collectively, the "Products"), we may request that you disclose to us personal data relevant to the establishment of a business relationship with you (including for anti-money laundering and customer due diligence checks) and for operation of the Platform and Products. We may also collect personal data from other sources, including from third party background checks, registered credit reporting agencies, regulatory authorities, central depository or depository agents, and web cookies and Platform activity.

What we use your personal data for

Sisters Inspire only uses and processes your personal data for purposes relating to our business activities (including the operations of our Platform and your participation in any of our Products).

Sisters Inspire may (without limitation) use and process your personal data:

a) for the purposes set out in the rules of Products which you participate in (including to assess and process, and to enable others related to the Products to assess and process, your request

- for services or options within a Product);
- b) to identity and credit checks, and to conduct due diligence for our customer onboarding process and for our continuing business relationship with you;
- c) to communicate with you (including to send you information, updates or other materials on our Products which may interest you);
- d) to carry out market analysis and research, and customer profiling to gauge industry and market trends;
- e) to provide information to regulatory and governmental authorities or other persons in compliance with its obligations under law; and
- f) for internal administrative purposes.

Who has Access to your Personal Data?

Personal data held by us will be kept confidential, and will not be disclosed to third parties except as provided below.

The Platform is a tool for facilitating transactions between the various participants in a Product. Accordingly, the rules of a particular Product, other participants in a Product may be provided access to or given disclosure of your personal data to the extent that such disclosure or use will facilitate the execution and operation of the Product.

Sisters Inspire may, from time to time, engage other persons or service providers to perform certain functions for or on our behalf, to administer and give effect to transactions relating to the Platform or to comply with legal, governmental or business prudential requirements. In doing so, we may provide access to or disclose your personal data to such service providers including, but not limited to those listed below:

- a) entities related to Sisters Inspire;
- b) our agents, contractors, vendors, service providers and business partners (e.g. information technology service providers, insurance providers);
- c) credit reporting agencies and third party due diligence database service providers (e.g. CTOS, RAMCI, Credit Bureau Malaysia and WorldCheck);
- d) banks and financial institutions;
- e) professional advisors and external auditors; and

f) regulatory and governmental authorities (any person to whom we are under an obligation to make disclosure under law).

Your Rights to Access and Correction

You can request to see your personal data and, if the personal data is inaccurate, you may request that we update it. You may do so through the Platform, or if an avenue is not provided on the Platform, by sending us an email at admin@sistersinspire.com.my. Please allow us reasonable time to respond and effect any change pursuant to requests made by email.

Withdrawing or Limiting Consent

We will retain and process any personal data supplied by you for as long as necessary for the fulfilment of the purposes set out in this Notice or as is required to satisfy any legal, regulatory or accounting requirements.

If you choose not to furnish any mandatory personal data requested or wish to withdraw your consent or significantly limit the processing of your personal data, Sisters Inspire may be unable to process your personal data, and access to the Platform or a Product or any related services, may be curtailed. When you do so, you acknowledge that Sisters Inspire shall not be liable for any losses which you suffer as a result of your own action.

Conflict and Amendments

In the event of any conflict between the English language version and the Bahasa Malaysia version of this Notice, this English language version shall prevail. Sisters Inspire reserves the right to modify, update or amend this Notice from time to time. By continuing to communicate with Sisters Inspire or using the Platform, you signify your acceptance of such modifications, updates or amendments.

The current version will always be made available for reference on the Platform.
